- On April 04, 2024 Oil Marketing Companies (OMCs) comprising Indian Oil Corporation Limited (IOC), Hindustan Petroleum Corporation Limited (HPCL), Bharat Petroleum Corporation Limited (BPCL)] has initiated a tender vide joint EOI no. OMC/EOI/NUCO/BD/APR24 (CYCLE3) Tender ID - 2024\_MKTHO\_176473\_1 dated 4th Apr'24 for procurement of Biodiesel for total quantity bidding of **3,71,424 KL** covering the period from April 2024 to September 2024. Today, we have received partial allocation sheet for **1,87,713 KL** out of the total tender size mentioned above.
